RE: Class fee for online courses

By means of this memo I request implementation of a class fee in the amount of \$25 per credit hour, assessed to enrollments in online courses beginning with Fall term 2019.

Up to this time, online courses at UO have been delivered without consistent support systems. We have heard reports from students and faculty alike that the current level of support for online courses is inadequate. The proposed fee of \$25 per credit hour on fully online courses will fund resources to support student success in these courses. Faculty support will directly benefit students by increasing quality and consistency of online courses. The fee will not duplicate existing personnel, software, or services, but coordinate and expand current assets. Services and support funded by this fee are outlined in the table below.

With this fee, a call/chat center will be established. Additional personnel will be hired to staff extended hours at the help desk. Additional instructional designers and video production personnel will be hired to aid faculty in design and delivery of online courses. Faculty will receive training in pedagogy and online quality standards; they will have access to technology resources for enhanced content creation.

Care will be taken not to duplicate fees. For example, a per-course fee for exam proctoring has historically been attached to a small group of online courses. The previous fee will be eliminated in recognition that proctoring services will now be supported for all online courses.

Compared with other universities

Universities across the nation use a variety of means to fund online courses and programs. Many institutions charge a per-credit online fee. Looking at our peer AAU institutions, we find some that vary their fees on a course-by-course basis. **Iowa State**, for example, charges delivery fees for online courses that range from \$50 to \$570. Similarly, **Texas A & M** levies an additional charge for online courses that may range from \$40 per credit hour to \$550 per credit hour. **Ohio State** charges a fee of \$100 per online student. Other universities, such as **Oregon State**, charge a flat rate for online courses that combines tuition and fees.

A standard per-credit fee across all online UO courses helps to normalize support for online students and faculty, enhancing predictability and quality assurance. For simplicity of comparison, institutions included in the table below all charge a *consistent per-credit fee across all online courses*. A conversion rate has been calculated for universities operating on semesters rather than quarters.

Looking to the future

Online infrastructure and faculty support will directly benefit students by increasing the quality and consistency of online courses. As an added benefit, the framework built to meet current students' needs will pave the way for offering more high-quality courses in the future.

Our goal is to increase flexibility and reduce scheduling barriers by creating online courses that support timely degree completion. While *specific courses have not yet been selected*, the table below presents a snapshot of the *types of courses* that are high priority for early development, specifically:

- high-demand core education courses, especially gateway courses
- · courses that teach key, transferable academic and study skills to boost student success
- courses identified by academic units as bottlenecks within majors

By noting which courses UO students take online from other universities (transferring the credits back to UO) we gain additional insight into student preferences.
